RULES AND REGULATIONS OF TALENT DEMO 2025

1. Talent Demo is part of the official program of EnergaCAMERIMAGE Film Festival.
2. Talent Demo is produced by Tumult Foundation and European Film Center CAMERIMAGE (EnergaCAMERIMAGE Film Festival Organizer).
3. Talent Demo is an advisory program which aims to advise on the development and promotion of film projects. The Program is addressed primarily to film school students and young independent filmmakers.
4. Advice will be given by film industry experts invited to EnergaCAMERIMAGE 2025 Film Festival, which will be held in Toruń, between 15th and 22nd November 2025.
5. The meetings will be held only in in-person formula. This is the target and assumed formula of the Talent Demo 2025 program.
6. A typical group of experts might include representatives of the following professions:
 - cinematographer
 - director
 - distributor
 - producer
 - talent agent
7. Talent Demo participants will be selected based on their Application Forms (available after signing-up and logging-in on www.portal.camerimage.pl in the Talent Demo section) including a project description in English.
8. Applications will be accepted for consideration upon payment of **PLN 150,00**. This payment can only be made by credit card in the PayPro S.A. system.
9. If the participant withdraws their application or is not selected for the program, **fees are non-refundable**.
10. Projects rejected by the Organizers in previous years will not be reconsidered.
11. The Organizers will select Talent Demo participants based on submitted application materials. **Each participant will have two film industry experts assigned to them**, based on the requirements presented in the application.
12. After receiving the confirmation from the participants, the Organizer will send participants' projects to the experts for review in advance.

13. During EnergaCAMERIMAGE Film Festival, each participant will meet their assigned experts in order to discuss the project.
14. Each session with the expert will take **maximum 30 minutes** and shall be conducted in English. The decision to extend the session is taken by the expert concerned.
15. One participant can only introduce one project during the session.
16. During the consultation participants may present audiovisual material to the experts, upon prior notifying the Organizer. However, **the Organizer does not provide the media or equipment necessary for the presentation.**
17. The Organizer reserves the right to cancel a session with the expert and appoint another one with similar experience and profession. The Organizer will keep Talent Demo participants informed about any changes.
18. Deadline for Talent Demo application submissions: **15 October 2025.**

a) keeping records (applications and selection of projects), preparation and organization of the EnergaCAMERIMAGE Festival, in connection with the submission of your project as part of the Talent Demo program at the EnergaCAMERIMAGE Festival and acceptance of the Regulations for recruitment to the Talent Demo program organized as part of the International Festival of the Art of Cinematography EnergaCAMERIMAGE - in connection with Art. 6 sec. 1 lit.b) GDPR. We will process your data provided in the application form for the period necessary to organize and conduct the Festival, including the selection of winners in the given categories of Competitions for the period necessary to organize and conduct the Festival, and in the scope of the statutory objectives, i.e. documenting previous editions of the festival, contributing to promoting cinematography as art of international scope, including for a historical purpose in connection with Art. 6 sec. 1 lit. f) GDPR until the end of the Administrator's activity.

b) disseminating, informing and advertising the Festival in the media (press, TV, radio, Internet), documenting the course of the Festival and publications on the Administrator's activities, in connection with the Administrator's statutory activities, as well as for information and confirmation of the implementation of the sponsorship agreement - in connection with the protection of the legitimate legal interest of the Administrator, in accordance with art. 6 sec. 1 lit. f) GDPR. For this purpose, we will process your image, name and surname or nickname until you raise a justified objection or request that the processing of your personal data be restricted. The Administrator informs that the Festival will be documented in the form of photos and videos, on which images and voice recordings of the Festival Participants may appear,

c) setting up and maintaining a free account on the EnergaCAMERIMAGE website (www.portal.camerimage.pl - in connection with art.6 par.1 or b) GDPR - until you delete your account or for two years from the moment of inactivity (not logging in) on your account,

d) contacting you in matters related to the organization of the Festival and the selection of submitted projects, answering your questions, requests or complaints - in order to protect the legitimate interests of the Administrator, in connection with art. 6 sec. 1 lit. f) GDPR - we will process your data in the form of your first and last name, name and contact details or the content contained in your requests until we answer you and resolve the matter, no longer than 2 years from the end of the calendar year in which it is finally we took care of your affairs,

e) protection of the legitimate interests of the Administrator, i.e. for archiving and statistical purposes and for pursuing any claims that may arise in connection with the submission of your projects to the Festival and participation in the Festival. Your data will be stored until the cessation of possible claims and for the implementation of the above-mentioned. purposes, transfer of data to other entities authorized by law (implementation by the Administrator of obligations imposed by law) - in accordance with art. 6 sec. 1 lit. c) GDPR, i.e. in particular on the basis of the provisions of tax law, the Accounting Act, and social security (e.g. for the purpose of making tax settlements or related to accounting and reporting).

4. We obtained your data directly from you during the first contact (eg when creating an account on the portal or completing the project application form for the Talent Demo program).
5. The administrator has appointed the Data Protection Officer, supervising the correctness of the processing of personal data, who can be contacted in any matter regarding the processing of your personal data by the Administrator by e-mail to the following address: rodo@camerimage.pl or in writing to the address of the Administrator's seat.
6. Categories of relevant personal data - we process your personal data to the extent necessary to implement the above-mentioned the purposes for which we obtained the data. These are data such as: name and surname, nickname, date of birth and contact details (email address, telephone number).
7. Each person whom we process personal data in the above-mentioned purposes, has the right to request the Administrator to access his personal data, receive a copy of it, the right to rectify it, delete or limit processing, the right to object to processing. In addition, you have the right to withdraw your consent at any time, as long as the processing takes place on the basis of your consent without affecting the lawfulness of the processing which was made on the basis of consent before its withdrawal and the right to transfer data, provided that the processing of personal data takes place. in an automated manner.
8. You have the right to lodge a complaint with the supervisory body - the President of the Personal Data Protection Office, if the Administrator violates the provisions on the protection of personal data while processing personal data;

The recipients of your personal data, depending on the purpose of processing, may be: entities authorized by law to obtain personal data on the basis of legal provisions (e.g. ZUS, Tax Office, UODO), entities / persons cooperating with the Administrator as part of statutory activities and commissioned cooperation agreements, i.e. co-organizers of the Festival, providers of technical and organizational services (e.g. as part of the provision of IT, hosting, cloud (cloud computing), legal, auditing and consulting services, accounting services), as well as agencies, advertising companies, banks, companies providing services courier and postal services, sponsors (sponsors) of the Festival in a given year - in terms of providing the image, recordings, names (first and last name, artistic nickname) and information about the awards received, Competition participants - the full list of Sponsors is always available on the Administrator's website: www.camerimage.pl. The co-organizer of the Festival is the European Film Center CAMERIMAGE with its office in Toruń, which processes the personal data of Festival participants, including persons submitting audiovisual works as part of the Contests and CAMERIMAGE Portal users on the basis of a personal data entrustment agreement concluded with the Administrator. As a co-organizer of this year's and subsequent editions of the Festival, he processes your personal data in order to prepare the EnergaCAMERIMAGE International Film Festival of the Art of Cinematography at the highest possible level.
